PROBLEM ANALYSIS

- EU: one of the heaviest alcohol drinking regions worldwide
- High social, medical & economical costs of harmful drinking; emerge both on an individual and societal level
- BI: most effective in the management of alcohol consumption for non treatment-seeking harmful drinkers
- To date, most evidence of BI has been gathered in PHC
- WHO/NICE: extension of BI implementation in settings beyond PHC:
 - workplace health services
 - emergency care
 - social services



General objective - BISTAIRS aims ...

- to foster BI implementation in relevant settings
- to provide a substantial contribution to the EU strategy to reduce alcohol related harm
- to increase the impact of secondary alcohol prevention in the EU
- to contribute to a reduction of the negative social consequences of harmful alcohol consumption in the EU
- to decrease the EU wide identified attributable health risks, i.e early death, illness, alcohol related accidents and violence.
- to contribute to the reduction of the tangible costs of alcohol related harm

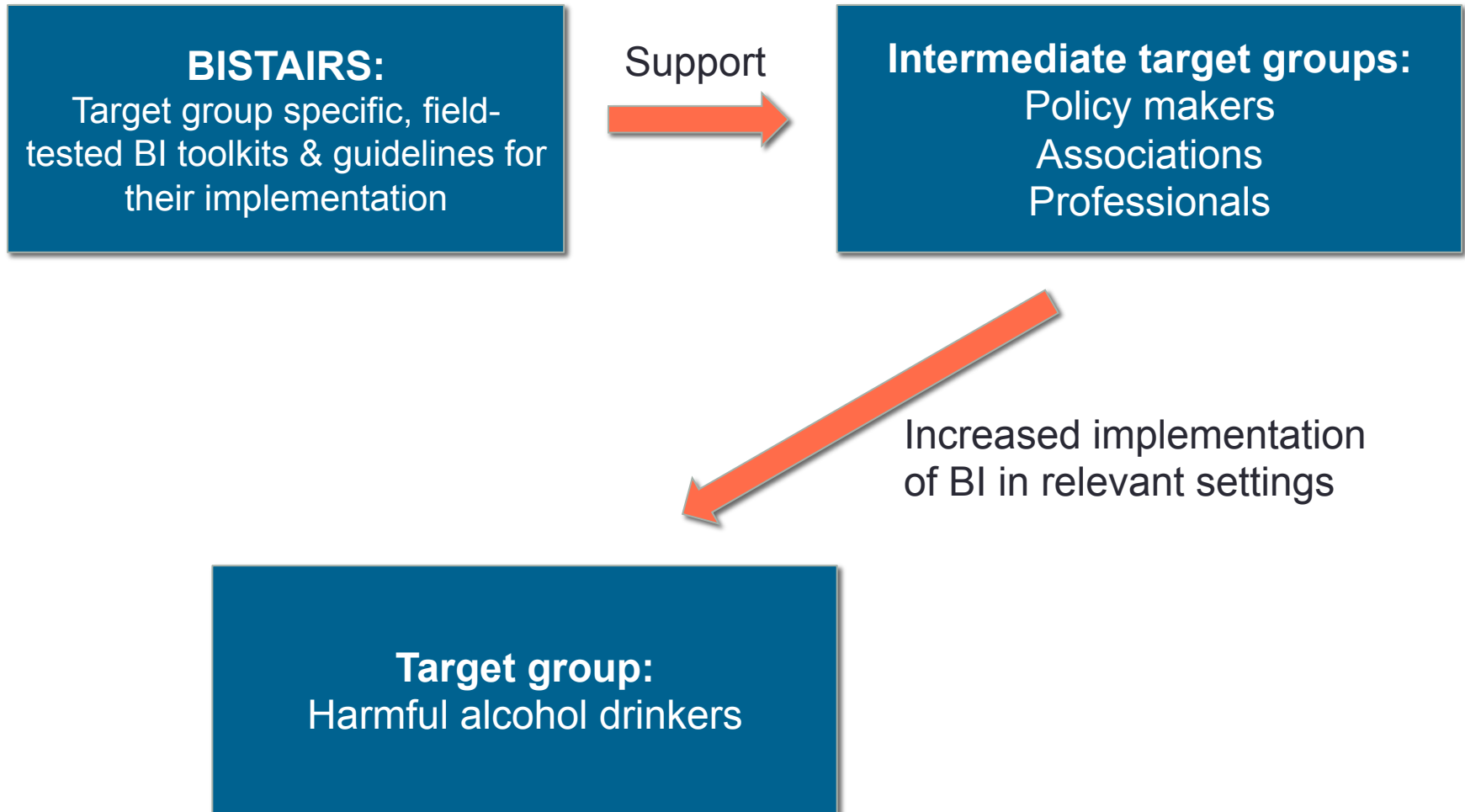
